- I understand that the animal being fostered is a “rescued” animal and the UDR cannot make any guarantees about the animal’s previous care, treatment or history. _____ (Initial)
- I understand and agree that, while the UDR makes every effort to place only healthy and sound animals, they cannot guarantee the health of any animal. The UDR shall not be held responsible for any unauthorized medical expense which may be incurred while the animal is in my care, hereby expressly excluding any implied or express warranties, merchantability, or fitness for any particular purpose, including without limitation and warranties regarding health, temperament or whether the animal is housebroken. Any special medical instructions will be followed as prescribed. _____ (Initial)
- I agree that the animal is being fostered will not be sold, adopted, or given to another party without the prior and written approval of the UDR. _____ (Initial)
- I agree that the animal will not be allowed outdoors without proper supervision. When taking the dog outdoors outside of a fence, they will be on a secure harness and wear proper ID. _____ (Initial)
- I agree that this dog is to be a companion animal, not a guard dog. The dog will live inside my home, not outdoors. _____ (Initial)
- I agree to care for the animal in a humane manner and be a responsible animal guardian. This includes supplying human grade food, water, shelter, attention, and authorized medical care. _____ (Initial)
- I agree that if at any point I cannot take care of the animal, I will return him/her to a representative of the UDR. _____ (Initial)
- I understand and agree that the UDR makes no guarantees about the animal's health and is not responsible for any unauthorized medical costs incurred by the animal while in my possession. I agree to foster the animal “as is” and assume all responsibility for the treatment of all existing conditions or any other conditions or physical changes that may occur while in my care. _____ (Initial)
